## DxF Updates

- Thank you to the over 230 participants at the 2025 DxF Summit! The discussions that took place about interoperability, return on investment, whole person care, and more are important and will continue to shape the DxF for years to come.

- **As a reminder**, CDII has added a new answer to the [Data Exchange Framework FAQ](#).
  - This answers if health plans and insurers are required to share adjudicated claims, encounter date, and clinical elements in the USCDI with all DxF Participants, or only with Individuals through Individual Access Services.

## DSA SIGNATORY GRANTS:

- DSA Signatory Grantee Progress Reports with Milestone achievements submitted by the March 31, 2025 deadline are under review. If approved for payment, disbursement will occur by April 30, 2024.

## SOCIAL DATA EXCHANGE (TASC):

- CDII kicked off the 2025 Technical Advisory Subcommittee (TASC) with the first meeting of the Social Data Exchange focus group on Thursday, March 27, 2025. Participants discussed the challenges in exchanging social data bilaterally among human services organizations and between human services and health care organizations. Future meetings will discuss and refine a proposed reference architecture for exchanging health and social data using DxF. - Remember that CDII has published the final [Data Exchange Framework \(DxF\) Roadmap](#) which includes a pillar describing how the state and stakeholders can work together to advance social services and social data exchange.
