DxF Updates

- CDII is hiring a Deputy Director to oversee and manage statewide Data Exchange Framework implementation. The final filing date is December 20, 2024. Those interested can apply on [CalCareers](#).

DXF ROADMAP:

- CDII has released a draft of the [DxF Roadmap](#) for public comment. CDII developed this DxF Roadmap to identify and communicate a set of DxF implementation priorities and proposed steps and milestones to implement them through 2027. - CDII has released a [Request for Information \(RFI\)](#) for a statewide service that both providers and recipients of events, such as admissions and discharges, can use to manage requests for notifications of those events to support a key DxF Roadmap objective. **If you are interested in commenting on if or how such a service might be created, please respond to the RFI or share with others in your network who may be interested. Responses to the RFI are due December 20, 2024.**

POLICIES AND PROCEDURES:

- CDII has posted a proposed amendment to the [Data Elements to Be Exchange P&P for public comment](#). This amendment proposes to advance requirements for DxF participants to exchange the US Core Data for Interoperability (USCDI) from version 2 to align with the version required by the U.S. Assistant Secretary for Technology Policy/Office of the National Coordinator for Health Information Technology (ASTP/ONC). **Responses to public comment are due January 2, 2025.**
