*The Center for Data Insights and Innovation (CDII) is providing this bi-weekly communication to provide important updates and information on the Data Exchange Framework (DxF).*

## DxF Updates

- CDII has developed a [Participant Directory User Guide](#) to explain the process of Participant exchange of Health and Social Services Information (HSSI). - CDII has released a call for applications for Technical Advisory Subcommittee (TASC) members for 2025. CDII is seeking subject matter experts with technical and operational expertise to advise CDII on:
  - Identity management
  - Consent management
  - Social services information exchange

## DXF ROADMAP:

- The format of the TASC is being changed for 2025. Rather than assemble a single subcommittee with broad membership to discuss and advise CDII on multiple topics, CDII will be convening the TASC as a collection of four focus groups. Each focus group will be comprised of members from multiple stakeholder groups with expertise specific to a topic highlighted for action in 2025 in the DxF Roadmap. The TASC will continue to meet in four short series of open meetings.
