



# DxF Bi-Weekly Update

*The Center for Data Insights and Innovation (CDII) is providing this bi-weekly communication to provide important updates and information on the Data Exchange Framework (DxF).*

## DxF Updates

- CDII has published the final [Data Exchange Framework \(DxF\) Roadmap](#) to the DxF webpage.
  - The DxF Roadmap describes how the state and stakeholders can work together through 2027 to collectively invest in data exchange efforts that advance whole person care, leveraging efforts across the health and human service ecosystems, inside and outside of government. CDII collaborated with the DxF Implementation Advisory Committee (IAC), CalHHS state departments, and other subject matter experts and stakeholders to develop the DxF Roadmap. Feedback received during a public comment period in Fall 2024 also informed the Roadmap's final recommendations. CDII will play a leadership role in convening stakeholders and advancing the Roadmap's recommendations through 2027. Stakeholders are encouraged to review and share the Roadmap within their networks to assess opportunities to support and align to data exchange priorities in California.
