TECHNICAL ADVISORY SUBCOMMITTEE (TASC) SOCIAL DATA EXCHANGE:

- CDII held the fourth and final meeting of the 2025 Technical Advisory Subcommittee (TASC) Social Data Exchange focus group on **Thursday, May 8, 2025**. Participants discussed priority use cases, data access and privacy, and the capabilities required to support social data exchange.
