



DxF Bi-Weekly Update

The Center for Data Insights and Innovation (CDII) is providing this bi-weekly communication to provide important updates and information on the Data Exchange Framework (DxF).

DxF Updates

- A key goal in CDII's DxF three-year roadmap is to establish a statewide structure for communicating significant events to all authorized DxF Participants that request them. As a step towards this goal, CDII has posted a Request for Information (RFI) for a statewide service that both providers and recipients of events, such as admissions and discharges, can use to manage requests for notifications of those events. **If you are interested in commenting on if or how such a service might be created, please respond to [the RFI](#) or share with others in your network who may be interested. Responses to the RFI are due December 20, 2024.**
- CDII has released a draft of the [DxF Roadmap](#) for public comment. CDII developed this DxF Roadmap to identify and communicate a set of DxF implementation priorities and proposed steps and milestones to implement them through 2027. **[Responses to public comment](#) are due December 9, 2024.**

QHIO PROGRAM:

POLICIES AND PROCEDURES:

- CDII has posted a proposed amendment to the [Data Elements to Be Exchange P&P for public comment](#). This amendment proposes to advance requirements for DxF participants to exchange the US Core Data for Interoperability (USCDI) from version 2 to align with the version required by the U.S. Assistant Secretary for Technology Policy/Office of the National Coordinator for Health Information Technology (ASTP/ONC). **Responses to public comment are due January 2, 2025.**
