## STANDARDS ADVANCEMENT:

- HCAI does not anticipate convening a Standards Committee to discuss further technical standards advancement in 2025. See the [Technical Standards Advancement Process](#) for more on how HCAI considers new technical standards for DxF.
- As a reminder, the [Data Elements to Be Exchanged P&P v1.2](#) has been amended to update USCDI requirements to version 3 effective January 1, 2026 as recommended by the 2024 Standards Committee and to align with federal health IT certification requirements.
- The proposed amendment to the Technical Requirements for Exchange P&P included proposed new standards requirements to advance event notification.
  - Thank you to all that participated in the public comment period for this proposed amendment.
  - HCAI anticipates discussing some of the proposed amendments and public comments to those proposals at the upcoming IAC meeting on January 25, 2025. Please join us for that meeting to learn more.
