DSA SIGNATORY GRANTS:

- **The DSA Signatory Grants Program will end today, March 31, 2026.**
 - All Progress Reports indicating achievement of a Milestone must be submitted by today, **March 31, 2026**.
 - HCAI and PCG will reach out to Grantees if additional information is needed upon reviewing submitted applications.
 - Grantees or their selected QHIO who do not submit a Milestone Progress Report by this date will no longer be eligible to receive any undisbursed grant funds.

 - This update to the DSA Grants Guidance Document includes changes to the final progress report submission deadlines and changes to the rule for grantees to switch QHIOs.

DSA SIGNATORY LIST AND PARTICIPANT DIRECTORY LISTING UPDATES:

- HCAI DxF will be adding two new columns to the weekly published DSA Signatory List **starting April 1, 2026**. The two columns will populate a Participant's business street address and California License Number, as provided during DSA Signing Portal Account registration. *Participants are asked to verify that your organization's information is accurate and up to date.* Updates to business address and / or license number can be made on the DSA Signing Portal by the registered user.
- HCAI DxF will also be updating the weekly published DSA Signatory List and Participant Directory Listing to remove references to 'Delay Exchange to 1/31/2026' and replace them with 'NA'. This change will go into effect **starting April 1, 2026**.

STAKEHOLDER ADVISORY COMMITTEE:

- HCAI has selected members of the Data Exchange Framework (DxF) Stakeholder Advisory Committee, established pursuant to Senate Bill 660 to advise the department on health and social services information technology issues and to support updates to the DxF data sharing agreement and related policies and procedures. [Read the SB 660 implementation fact sheet.](#)
- The Advisory Committee will initially serve as a forum for stakeholder and public engagement to inform recommendations to HCAI and support preparation of a report to the Legislature on the continued implementation of the DxF. The Advisory Committee will continue to meet ongoing to advise on the administration of the DxF program.
- Advisory Committee members represent a broad cross-section of California's health and social services ecosystem, including health plans, hospitals, physicians, clinics, community-based organizations, health IT, privacy and security professionals, consumer advocates, organized labor, and county social services.
- The Advisory Committee will develop recommendations by January 1, 2027, including proposed statutory changes, training and technical assistance needs, and best practices to support collection of individual-level demographic and health-related social needs data. The Advisory Committee will also collaborate with HCAI on a report to the Legislature due July 1, 2027, addressing DxF participation,

compliance pathways, governance considerations, technical assistance needs, enforcement frameworks, and consumer experiences with data exchange.

- The Advisory Committee will begin meeting in April 2026, with meetings open to the public.
